for short-term engagement of 'Civic society strategy development expert'

I BACKGROUND

1.1.Beneficiary country The action will be implemented in Bosnia and Herzegovina.

1.2.Project description

Title: 'EU for Civil Society (EU4CS) - Capacity building of Governments to include CSOs into the decision-making, Bosnia and Herzegovina'

The *overall objective* of this project is to address the problem of weak cooperation and dialogue between governments and civil society in Bosnia and Herzegovina and to extend support to inclusive social dialogue and social partners (employees, employers, governments) including in relation to legislation, collective negotiations, assessing the need for new legislation, drafting the laws and monitoring the implementation of reforms.

The *specific objective* is to target the problem of weak cooperation and dialogue between governments and civil society in Bosnia and Herzegovina and extend it in direction of support to social dialogue and social partners (employees, employers, governments) including on such issues as legislation, collective negotiations, assessing the need for new legislation, drafting the laws and monitoring the implementation of reforms.

Expected *outputs* to be achieved include:

- Strengthen capacity of the public institutions and CSOs for better cooperation on policy dialogue,
- Strengthen capacity of the CSOs for better cooperation on creating and drafting strategic, legal and policy framework,
- Improved social dialogue between social partners (employees, employers, governments) at all institutional levels,
- Ensure participations of CSOs in the public consultations process/public debates on different institutional levels,
- Improved transparency in financing of CSOs by public institutions and
- Improved CSOs programme and financial reporting system to relevant institutions.

1.3.Background information

Since 1995 and according to the Dayton Agreement the state of Bosnia and Herzegovina has been divided into two political entities – the Republic of Srpska (RS) and the Federation of Bosnia and Herzegovina (FBiH) – and the Brčko District (condominium). The RS covers 49 % of the territory and forms a semi-circle around the north and east, while the FBiH occupies the other 51%. Each Entity has its own political structure and administration. The BiH State government consists of a Parliamentary Assembly, which is divided into a House of Representatives and a House of Peoples, a rotating tripartite Presidency (with one member from each of the constituent peoples – Bosniaks, Croats and Serbs), and a Council of Ministers with nine ministries. The political structure of the FBiH is divided into three levels: the Entity level, the Cantonal level and the Municipal level, with each municipality having its own municipal council and administrative structures. By contrast, the Republic of Srpska (RS) has no cantons, only municipalities.

Therefore, in such a complex environment non-state actors (NSA) have difficulties in advocating for reforms in the above mentioned areas.

According to the latest data obtained from the BiH Ministry of Justice, there are more than 27,000 organisations that can be considered as civil society non-profit organisations. At the State and Federation BiH level, the Ministries of Justices are responsible for registration and for keeping the Registry Books for Associations and Foundations. According to RS's Law on Associations and Foundations, associations and foundations register at the Basic Court in the seat of the District Court in the area in which they have their seat.

The West Herzegovina Canton (WHC) is one of the ten cantons in the Federation of Bosnia and Herzegovina and is located in the southwestern part of Bosnia and Herzegovina. The WHC borders the Herzegovina-Neretva Canton and the Herceg-Bosna Canton.

The WHC consists of four local self-government units, i.e., two cities and two municipalities, and according to the 2013 population census, it has 94,898 inhabitants, of which 50% are women. According to the 2013 census, the number of households was 25,081, with an average of 3.77 members per household. According to the 2013 census, WHC had 94,898 inhabitants, and according to the estimated population in 2023, as conducted by the Federal Institute for Statistics (FZS), there were 92,305 inhabitants in the WHC.

According to the data from the aggregate register of Associations and Foundations in Bosnia and Herzegovina, there are a total of 771 active Associations registered at the Ministry of Justice and Administration of the West Herzegovina Canton.

1.4. Current state of affairs in the relevant sector

In regards to civil society in BiH¹, no progress was made in addressing the Opinion key priority 11 on ensuring an enabling environment for civil society, notably by upholding European standards on freedom of association and freedom of assembly. An empowered civil society is a crucial component of any democratic system and should be recognised and treated as such by public institutions. While the overall legal and regulatory framework governing establishment and functioning of civil society organisations is broadly in line with the EU acquis, much remains to be done for public institutions to ensure an enabling environment for civil society, including on freedom of association and of assembly, in line with Opinion key priority 11.

None of the existing governments' levels in BiH have adopted Strategy for development of civic society. However, Ministry of Justice BiH, with strong involvement of civic society organizations, drafted Strategy of BiH Council of Ministers for creation of a stimulating environment for development of civil society 2024-2028 which still need to be adopted.

There are four Laws on associations and foundations (on three institutional levels) in BiH with in general the same content which allows CSOs registered in Brcko District, or in any of two entities or on the BiH level, to operate country wide without any restrictions.

Ministry of Justice and Administration West Herzegovina Canton has prepared a Draft Law on Associations in the West Herzegovina Canton, which regulates the operation, establishment, bodies, and legal status of associations, registration, property, responsibility, termination of work, and removal from the Register, status changes, supervision, and other issues important for the operation of associations registered under this law in the West Herzegovina Canton. A public discussion on the draft has been conducted, and adoption is planned for 2025.

BiH E-register of associations and foundations of Bosnia and Herzegovina is not providing updated data on CSOs in BiH. Although nominally looks well developed (approx. 27.000 CSOs, Civic legislation generally in line with key international documents on human rights, several signed Agreements for cooperation among the authorities and CSOs etc.), within BiH civic society is hardly possible to identify exact number of CSOs (approx. 2/3 of CSOs in BiH don't submit their annual

financial report), transparency in distributing public funds to CSOs suffer from lack of transparency, majority of CSOs lack key resources – particularly human and financial, charts of accounts are partially adjusted to needs of CSOs, donations represent 92% of all resources available to CSOs, where share of public funds in total revenue of CSOs is 34,4% (EU average - 58%) and most CSOs still largely depend on foreign support.

Since civil society plays a key role in the development of democratic processes, the improvement of societal values, and the promotion of active citizen participation in social and political matters, Government of the West Herzegovina Canton during November 2024 adopted decision for creation the Strategy for the Development of Civil Society of the West Herzegovina Canton for the period 2025-2030. The strategy should provide a framework for development of civil society in WHC but also for improving cooperation between CSOs and government institutions at the local and cantonal levels, thereby achieving better coordination and effectiveness in addressing common problems and implementing public interest projects.

The strategy should provide a framework for systematically addressing the existing challenges faced by CSOs in the canton, including the lack of institutional support, limited financial resources, weak coordination, and insufficient integration into decision-making processes.

The process of developing the Strategy for the Development of Civil Society in the West Herzegovina Canton 2025-2030 is led by the Office of the Government of the West Herzegovina Canton for European Integration.

II SCOPE OF THE ASSIGNMENT

2.1. Purpose of the assignment

Civic Society Strategy Development expert on (hereinafter referred to as "Expert") has to facilitate and draft the Strategy for the Development of Civil Society in the West Herzegovina Canton 2025-2030 (further – the Strategy), in line with methodology endorsed by *Office of the Government of the West Herzegovina Canton for European Integration* of the West Herzegovina Canton and in close cooperation with working group consisted of representatives from the public, and civil sectors from West Herzegovina Canton.

It is envisaged that the Expert will perform its duties according to the following framework:

- Related work plans, timeframes, methodologies and relevant data assessment should be agreed with the Office for European Integration of West Herzegovina Canton and EU4CS,
- The elaboration of the Strategy, will be provided according to the methodology endorsed by the Office of the Government of the West Herzegovina Canton for European Integration. This also should consider the relevant international standards and regulations (e.g., DG NEAR Guidelines for EU Support to Civil Society in the Enlargement Region 2021-2027 etc.) and available reports and/analysis and
- Final draft of the Strategy should be accepted by the Office of the Government of the West Herzegovina Canton for European Integration.

2.2. Geographical area

The geographical area to be covered is West Herzegovina Canton, in accordance with the competences of the Government of West Herzegovina Canton.

2.3. Target group

During the process of developing of planned Strategy, the following members of target group are to be engaged (directly in content development and/or during consultations on draft Strategy content):

- Municipality of Grude;
- Civic Society Organisations (social and health sectors, sports, culture, entrepreneurship, environment, youth, recreation, art, employers' associations etc.);

- Academic community;
- Project EU4CS.
